## Taking Pride in our Local **Green Space**

Queen's Crescent Garden has come a long way over the last decade as the community implemented an ambitious regeneration Masterplan and formed the Trust to own the 125 year lease. Recalling the time when its use had become almost exclusively antisocial, it is now very pleasing to see diverse community members enjoying what this precious space has to offer.

However, we are all aware that there are still occasions when activity is not acceptable. Use of the Garden for all antisocial behaviour, ASB, needs to become a thing of the past, and the Police are keen to support us. Very occasionally reports reach the Trust Directors of instances of particularly distressing ASB. Please do report such incidents directly to the Police so they can assist as appropriate. The Trust has received very positive comments to the news that Safer Central Exeter funding includes installation of 24hr monitored CCTV cover of the Garden and vicinity. This is expected to act as a deterrent as well as providing evidence of ASB when required.

In May 2021, the Home Office awarded Exeter £432,000 to make our city safer. As a result of this a project, named Safer Central Exeter, has been set up and is led by a partnership which includes the City Council, police, businesses, neighbourhood watch and other community groups.

Exeter is a vibrant, lively place enjoyed by a mix of residents, visitors, students and businesses. The city centre welcomes about 67,000 people every day and, though it is made up mainly of shops and businesses, lots of people also call it home. The key areas of focus of the project are the very central streets of Exeter including Sidwell Street and Queen's Crescent Gardens, but everyone in St James can benefit.

Note 1/20. It lays out 5 essential pre-requisites for cycle paths. The current suggested provision fails on all criteria but "directness".

Look further at the Government paper 'Gear change - a bold vision for cycling and walking' and of the 22 suggested planning essentials the Union Road scheme might adhere to 4 of them. Importantly it states in section 20 that; 'All designers of cycle schemes must experience the roads as a cyclist' and 'Ideally, all schemes would be designed by people who cycle regularly'.

Cycling safety is important, but equally important is pedestrian care and the realistic wishes of local residents. It's an enigma the present plans don't even start to address.'



## **Crime Prevention**

As part of the Safer Central Exeter scheme residents in St James can attend a free Home Safety/Crime Prevention course. This will cover personal safety and how to deter crime at home, and alarms, torches and credit card protectors will be distributed. Another initiative is to supply residents with Property Marking Kits these will also be free and will mark up to 50 items in your home. 

## Coronavirus cases at the University and in St James 2020-2021


In the summer of 2020 many residents of St James were greatly concerned about the imminent return of students to Exeter University and the effect that that would have on the number of Coronavirus cases in St James. It turns out that such concerns were well justified:

Examination of the bar charts produced by Exeter University of University Coronavirus cases reveals that the number of Coronavirus cases amongst students did indeed soar to extremely high levels in October 2020.

After many months, and much lobbying by University staff, the University did eventually start to publish online the number of Coronavirus cases it had recorded previously and was continuing to record among both staff and students. The University continues to publish daily, weekly and monthly Coronavirus case numbers at https://www.exeter.ac.uk/ coronavirus/statistics/ The daily and weekly figures give those for staff and students separately. It is most notable that the number of staff Coronavirus cases are a much greater proportion of all University Coronavirus cases in the academic year 2021/2022 than they were in 2020/2021, corresponding to a return to in-person rather than remote/online teaching. To put the numbers in context, Exeter University has around 6,000 members of staff and approximately 25,000 students.



How have the number of Coronavirus cases in St James overall fared over roughly the same time period? The Government publishes the Coronavirus case rate per 100,000 people in each Middle Super Output Area (MSOA) in

## Do you live in a Neighbourhood Watch area?

This is a question you may be familiar with when applying for house insurance, which is hardly surprising when the Police advise that even the display of Neighbourhood Watch (NW) stickers in windows and signage in streets, act as an effective deterrent to crime. Of course, a more active NW group is likely to be even more effective by encouraging vigilance and a community spirit where residents show a caring concern for each other and communication between police and the community is nurtured.

Part of Safer Central Exeter's funding is earmarked for Devon & Cornwall Community Watch Association (D&CCWA) to encourage, establish and support more widespread NW coverage of residential communities adjacent to the City Centre. The Trust has been approached by D&CCWA to look with them at the map of St James, note the streets already covered by the scheme, and look beyond these, to help identify additional potential mini-

neighbourhoods where residents might, if approached, be interested in forming a group. The aim is to offer all the chance to benefit from living in a NW area. A designated Group may be as small as a few houses, large enough to cover a number of streets, or anything in between - whatever each group feels suits them best.

Currently NW stickers are available free of charge to new groups as well as those already established, and the City Council will erect street signage to confirm the NW status. If you and your neighbours would like to get in straight away, get in touch via trust@exeterstjamesforum.org either identifying your established NW area or suggesting the properties to form your new NW group. In each case provide the name of a contact with whom D&CCWA might liaise in order to supply the free materials or, if invited by you, to come along to explain more and offer further support.

acutely affected EX4 area. He confirmed the critical element for many living in the vicinity is the removal of 89 parking spaces along the entire length of Union Road. If it is decided to proceed, the process would involve an advertisement by the County Council of the proposal 'to revoke the 89 spaces, most of which are paid for Resident Parking spaces'. Cllr. Prowse stated that 'the public response to this will be critical'.

It is not only the loss of parking spaces that concern local residents however. One has told us, 'As a cyclist, and Union Road resident, the questions I ask about schemes proposed are centred around Government Local Transport


