Clock Tower Hotel – another family home opportunity in jeopardy!

Clock Tower Hotel - another family home opportunity in jeopardy! The vision of St James Neighbourhood Plan (NP), for a balanced and vibrant neighbourhood was widely supported including by the University Student Guild. The consensus view was that a sustainable St James, good for all, is one where student residents are a significant, but not a dominant part of the community.

This is very relevant to a current application for change of use of Clock Tower Hotel, New North Road, a Grade II listed property, part of a gracious terrace in St David's conservation area.

Following failed applications for conversion to an 18 bed student HMO (house of multiple occupancy), Exeter College has submitted an NP policy Sustainable Development 3 (SD3) focuses on small application for boarding accommodation for up to 25 students aged between 16 – 18 years. The planning consultants have argued that as this proposal is for an entirely different cohort from the university students in HMOs, it would 'contribute to a mixed and balanced community'. It seems doubtful that many would agree.

The Forum can confirm that in 2017 at least one local builder responded to an invitation by Wilkinson Grant estate agents to make an offer to purchase the Hotel, crucially at the much-reduced asking price that the agent had told a meeting of local councillors, Forum representative and the Planning Officer would make conversion

to two family homes financially viable. The invitation proved empty - Wilkinson Grant ignored his cash offer! As long as planning permission is granted to developers of student accommodation who are willing to pay prices totally unrealistic for any other purchaser, development is bound to lead to further increase in community imbalance.

scale infill or windfall sites arising for example when commercial premises become vacant. Here development proposals will only be supported for affordable housing or high quality private residential

ESJF lobbies ECC to reduce letting boards

A proliferation of letting boards in an area has an adverse effect on the visual appearance of the neighbourhood and can be potentially off-putting for family buyers and renters. It also unfortunately highlights potential empty properties to burglars. Exeter St James Forum (ESJF) has been monitoring contraventions of a protocol which came into force in September 2014.

This protocol, active in St James and other areas of the city states that:

No 'To let' signs should be displayed during July or August or by the same agent on adjoining properties.

No 'Let by' or 'Let and Managed By' sign boards should be displayed, including for the fourteen day period allowed by law.

Our findings show that this protocol has been openly flouted since its inception.

ESJF, together with Cllr. Keith Owen, has been lobbying the City Council to instate a 'Regulation 7 Direction' meaning that the Secretary of State would impose additional control measures over such signboards within the protocol area. This has proved to be extremely effective in other parts of the UK, most notably in parts of Nottingham which now have a total ban on letting boards from October to January and only one single board is permitted per landlord/agent per street together with various other visual restrictions.

The Council is presently undertaking a letting board survey of St James and the neighbouring areas with a view to considering submitting such a request forthwith.

Encourage our Hedgehogs!

Hedgehogs have been seen recently in St James which is good news for this declining species. Hedgehogs need a large territory, travelling around a mile a night, and these sightings highlight the value of having good wildlife corridors in St James.

With a few simple steps, you can help encourage hedgehogs into your garden:

Build hedgehog holes so that they can pass through the garden from both sides. They need to be 13 cm wide and the same height to be able to pass through.

- Leave some logs and leaves in your garden. Hedgehogs love leaves and branches and will hibernate beneath them in winter.
- Avoid pesticides and weed killers these can harm hedgehogs and reduce their food supply.

If you can attract them to visit, they will return the favour by eating your slugs, so it's good for the rest of your garden too.

Queen's Crescent Garden - What's Next for the Regeneration?

The long-awaited continuation of the wall restoration has already seen the rebuild of the Longbrook / Queen's Crescent corner using reclaimed bricks kindly donated from various sources. This section of wall, already in poor repair, was badly damaged a few years ago when a car collided with it.

The value of mature trees in the Garden is undisputed. Following independent arboriculturist advice and consultation with Exeter City Council's Tree Officer, it was decided to retain all the yew trees along York Road to provide some protection from the traffic-related pollution, but to amend the 2014 concept design and remove the Western Red Cedar that has seriously damaged the Queen's Crescent wall and pavement. This will make way for the restoration of the full length of Queen's Crescent wall.

As a result of the tree and topographical surveys, a refined design was agreed at the Trust's AGM which sees the proposed York Road entrance moved a few metres further up to the corner of York Road and Queens Crescent as shown on this latest plan of hard landscaping elements, including layout of paths drawing people into and through the space.

Many hands needed to keep our community space spick and span!

We are looking for volunteers to join the mowing rota next year - working in pairs the whole job takes less than 2 hours. We also plan to create a year round weekly litter-picking rota and hope that 100 residents will come forward. Could you commit to just one week a year?

It has been very encouraging that a number of you have already been helping with simple maintenance tasks, including some anonymously in litter-picking. Exeter Round Table, Police

Cadets, University Staff, Community Student Volunteers and Clifton Emery Design have each provided a working party or two over recent years. Thank you to all! Please get in touch if you can help inany way.
